- Having significant concerns as to the current administration's attitude towards Bicester and its growth needs, specifically the withdrawal of funding for the realignment of Howes Lane, short notice of change, meeting with developers, no business case yet for the new proposal.
- On-going concerns with Howes Lane and how Oxfordshire County Council Highways Department are not listening to Bicester councillors or residents.
- The originally approved design for the Banbury Road Roundabout scheme is now over budget.
- A suggested meeting be held with CDC and OCC councillor's regarding the 20mph speed limit and parking restrictions.
- Concerns raised with the recent planning permission granted to build flats on the old Kings Antiques site on Queens Avenue.

**Cllr Sibley reported:**

- Cllr Sibley echoed Cllr Waines concerns regarding the Kings Arms Antiques Centre and Howes Lane.
- An East West Rail meeting took place on 23<sup>rd</sup> February 2022 – further information following this meeting will be available soon.

**Cllr Pratt reported:**

- Budget at CDC has been approved.
- A Healthy Town update was held at the John Paul II Centre with a very good attendance from difference voluntary groups.

- CDC is providing financial support that will encourage and assist local communities across the district to hold celebratory events during the summer of 2022.
