RESOLVED that the Committee **NOTED & REVIEWED** the Income, Expenditure and Variances Report to **Month 2.**

A query was raised on whether ledger code **102/4210 (Civic & Democratic/Mayor's Fundraising Expenses)** had budgeted funds – the Responsible Finance Officer explained that no budget is put to the code as the money spent for the mayor's events is offset by income received and recorded under **1013/102** code **Inc Civic Miscellaneous** which balances off the expenditure.

A query was raised as to why budget **106/4039 (Garth House/Waste Removal)** was 145.2% overspent – the Responsible Finance Officer explained that this was due to an invoice received in March 2024 that should have been paid in the previous financial year.

Responsible Finance Officer is to investigate the following:

- **Expenditure 110/4314 (Projects/Town Centre)** £587.00 was spent on for budget and update Cllr Ford.
- Look into the position of the Lease with for Whitelands, and whether rent can be acquired from the Café.
- **Budget 308/1028 (Whitelands Sports Village/Inc Pavilion & Pitches)** was budgeted for £93k last year but no budget is presented for the current financial year.
- **Budget 308/101 (Whitelands Sports Village/Inc Whitelands Room Hire)** Bicester Town Council doesn't take bookings for the Function Room, but money is put against the budget.
- **Budget 308/1016 (Whitelands Sports Village/Inc Whitelands Café)** £4,500 budgeted but Bicester Town Council do not charge rent currently.
- To check that the budget for the current financial year has been uploaded.

27/2425 Bank Balances

RESOLVED that the Committee **NOTED & REVIEWED** the bank balances at the end of **MAY 2024** and **NOTED** that Cllr Russell has signed the monthly bank reconciliation for the year to 31st May 2024.

A query was raised as the Bank Statement and Closing Balances did not match. The Responsible Finance Officer explained that the Bank – Cash and Investment Reconciliation Report was printed after 31st May and further transactions had been entered into the cashbook resulting in a difference between the bank and cashbook balances. Rialtas does not facilitate a specific date range so the Cash and Investment Balances reports will always show all current transactions on the date of printing. Going forward, where possible, until month end is completed, transactions will not be entered to prevent this from happening. The Responsible Finance Officer did have the Bank Reconciliations present to show the matching balances between the Cash Book and Bank Statements as of the 31st May 2024.

Pitchbooking Debtors:

CLlr Ford requested confidential papers for the next meeting with all outstanding debt from Pitchbooking.com so that councillors can see what clubs/users are accruing debt.

While trying to recover the debt, officers are asked to complete the following:

1. Overview

This is a standing report of the monthly Income & Expenditure to inform the Councillors of any possible overspending within the budget. Previously, the report was separated between the Detailed I&E and Variance Report. These have now been combined.

2. Background

Appended to this report is a detailed finance report showing the Council's expenditure to the end of *August 2024 – the fifth month* of the current financial year. The report compares expenditure against the full year agreed budget. Key variances that are apparent are summarised in an additional column with a final column demonstrating further estimated expenditure not within budget.

Structure and Interpretation of the Report

This is a "Cost Centre Report" and gives income and expenditure for each of the Council's cost centres (there are 15 in total). A cost centre is a separate service or area of expenditure, for example open spaces are one cost centre and the Garth House another. Each cost centre is given as a three-digit number with a narrative description beside it and they are:

- 102 Civic & Democratic
- 105 Central Services
- 106 Garth House
- 107 Garth Lodge
- 108 Corporate Finance
- 109 Community Support
- 110 Projects
- 300 Environmental Services
- 301 Open Spaces
- 305 Pingle Field
- 306 Sunderland Drive
- 501 Town Council Events
- 601 Cemetery
- 801 Street Scene

901 Earmarked Reserves (*allocations will be completed based on Council approval*)

There is a sub-total showing “Net Income over Expenditure” for each cost centre and at the end of the report a set of Grand Totals shows the total “Net Income over Expenditure” for the whole Town Council. On these totals a positive figure say **37,568** indicates that income was more than expenditure by that amount whereas a negative figure (in brackets) thus **(19,808)** indicates that expenditure exceeded income. Note that for all figures in this report a £ sign is assumed but not actually stated.

Within the costs centres the information is arranged in columns. Reading across the columns from left to right:

1. First column (no heading) is a four-figure digit which is the nominal code; a four-digit code that starts with 1 is an income code, if it starts with 4 it's an expenditure code Nominal codes describe the type of expenditure or income.
2. Second column (no heading) is a brief narrative description of each nominal code
3. Third column headed “Actual Last” (in a change to previous reports which had current month expenditure) is the figures for the previous financial year.
4. Fourth column headed “Actual Year To Date” is the part year figures for this year so for this particular report that's to the *end of August 2024*.
5. Fifth column headed “Current Annual Bud[get]” is the full year budget figures for the current financial year 1 April 2024 to 31 March 2025 as agreed by Council..
6. Sixth column headed “Variance Annual Total” is the difference between the actual expenditure to date (Column 4) and the Annual Budget (Column 5) a figure with brackets around it in this column indicates that the budget has been exceeded or that there has been expenditure where there was no matching budget. Sometimes this indicates unanticipated expenditure.
7. The seventh column headed “Committed Expenditure” contains purchase orders raised.
8. The eighth column headed “Funds Available” shows figures mainly the same as those in column six against expenditure codes. As more “commitments” are entered then the information in this column will be different from the sixth column due to the anticipated spend.
9. Ninth column headed “% Spent” shows the percentage of the budget spent (or received). So, in this report and for regular payments or income it would be reasonable to expect the final column “% spent” to show something in the region of 80% (being ten twelfths). Of course not all expenditure or income is spread evenly across the year and Councillors will be reliant on a specific commentary (below) from the RFO to identify areas where the figures are not where she would expect them to be at this point in the year (and where, in accordance with Financial Regulation 4.8 items are likely to produce a material variance of either £1,000 or 15% of budget at or before the year-end).
10. In our Internal Audit Year Ended 31st March 2024 – Year-End Audit Report by Mark Mulberry of Mulberry Local Authority Services Ltd, the recommendation in the Audit Findings was: ‘I would recommend the council use the Rialtas earmarked reserves functionality to record income and expenditure against the appropriate reserve.’ This has been completed and results in a tenth column demonstrating expenditure against reserves.
11. The eleventh column provides an explanation for the material variances illustrated in the ninth column.

12. The twelfth column is based on the request by Councillors that further expenditure expected before year end be provided. In this case, the estimated further expenditure not in the budget has been provided for clarification and transparency purposes. However, this is only an estimated amount and is open to alteration.

2. Other Information

Responsible Finance Officer was asked to investigate the following:

- **Expenditure 110/4314 (Projects/Town Centre)** £587.00 was spent on for budget and update Cllr Ford.
This is a supplier called Active Background Checks and is for DBS checks on all Council staff.
- Look into the position of the **Lease with for Whitelands**, and whether rent can be acquired from the Café.
At the time of creating this agenda, the Town Clerk was unavailable.
- **Budget 308/1028 (Whitelands Sports Village/Inc Pavilion & Pitches)** was budgeted for £93k last year but no budget is presented for the current financial year.
On investigation, there wasn't a budget for 1028 but there was a budget for 308/1014 of £30,000. The amount budgeted for income for Whitelands this year is £50,000, based on last year's income, we can expect another £35,000.
- **Budget 308/1017 (Whitelands Sports Village/Inc Whitelands Room Hire)**
Bicester Town Council doesn't take bookings for the Function Room, but money is put against the budget.
The Whitelands room hire is for the hire of a small room behind the reception area for a physiotherapist and not for the Function Room upstairs.
- **Budget 308/1016 (Whitelands Sports Village/Inc Whitelands Café)** £4,500 budgeted but Bicester Town Council do not charge rent currently.
At the time of creating this agenda, the Town Clerk was unavailable, however, perhaps the completion of the lease of Whitelands was expected to be completed within the year and rent claimed.
- To **check that the budget** for the current financial year has been uploaded.
The budget had been uploaded according to the Budget Sign Off Report of 19th December 2023.

1. Overview

Appended to this report is a detailed report showing accurate recording of all the Council's bank balances as at 10th September 2024.

2. Background

Structure and Interpretation of the Report

The report generated by the accounting system is a consolidated bank reconciliation for each of the Council's bank accounts. At the top section of the report, it lists the bank statement balance for each account. The bottom section lists the cashbook balances for each account. Ideally the balances will duplicate each other demonstrating that each account has been reconciled to its bank statement.

There are some accounts shown that are no longer in use – these are the Santander Deposit Account, Petty Cash and the Barclays Base Rate Tracker - these accounts are shown with a nil balance. The accounting system holds historic transactions for each of these accounts and therefore will not permit them to be deleted.

Bank Accounts in use are:

Barclays Current Account – most the council's financial transactions pass through this account. A Bank – Cash and Investment Reconciliation Report was printed after the 10th September .

Wages Account (held at Barclays) – a transfer is made monthly to this account to cover the costs of payroll. Astral is our payroll provider (which operates as a BACS bureau – making salaries and wages and disbursements to HMRC and Oxfordshire pensions on behalf of the Town Council). Historically, the separate account was to facilitate the automation of this process and enable the provider to take a direct debit without access to the main current account, however, we now monthly make a BACS payment to Astral and do not have a direct debit.

Ticketsource Account – also known historically as the Carnival Account (and the means to change that description within the accounting system is proving elusive) this account receives event ticket receipts from the ticket sales provider (current Ticketsource).

CCLA Deposit – this is an investment account, and the balance remains constant at £2m. The return on this investment, which was *£8,797.77 for August and £8,552.77 for July 2024*, is paid into the Barclays Current Account.

Barclays Treasury Deposit – this is the deposit account linked to the main current account and surplus funds from the current account are moved here.

Santander Capital Account and **Lloyds Treasury Account** are both non-interest bearing accounts that are little used.

3. Recommendation

As per Financial Regulation 2.2, the committee is asked to **REVIEW** and **NOTE** the attached report detailing bank balances at the end of **August 2024** and **NOTE** that Cllr Russel has signed the monthly bank reconciliation for the year to 31st August 2024.

4. Pitchbooking Debtors

Our Rialtas and Pitchbooking systems are not linked and transactions taking place through Pitchbookings do not appear on Rialtas. Unfortunately, on further investigation through the Pitchbooking records for 2023/2024, we discovered that many pitches booked had not been paid for and the total debt owed was £20,411.67. - i. Talent ID were notified of the arrears, and they said they would pay. They were sent 3 chase emails and have now been put on STOP due to lack of response and payment.
- ii. One-off individuals. We have contacted these individuals and payment has not been made. They are not regular users of the facilities.

- iii. Whitelands FC. I have sent 3 chase emails and other correspondence. Paul Canning held a formal meeting with Whitelands FC and they explained that if they were to pay off the debt immediately, they would have to close the club. There had been an internal mix up whereby the invoices were not being sent on to the correct person for payment. They are very concerned and would like to work with the Council to create a payment plan over 18 months so that we are able to collect the arrears, and they are still able to operate.

5. Proposal

- i. As Talent ID have been put on STOP, until the amount is paid, they will remain on STOP and the amount will be written off as bad debt, see bad debt report.
- ii. One-off individuals. We write these off as bad debt as we cannot chase them and they do not use our facilities on a regular basis, see bad debt report.
- iii. Whitelands FC
 - a. Option 1: Agree to the payment plan of 18 months but have the conditions that they go onto PAY As You Go until the debt is paid off and if they miss a payment due date by 5 working days of the payment plan, they are put on STOP. They will be asked to create a standing order to ensure payment is made on time.
 - b. Option 2: : Agree to the payment plan of 18 months but if they miss a payment due date by 5 working days of the payment plan, they are put on Pay As You Go. They will be asked to create a standing order to ensure payment is made on time.
 - c. Option 3: They must pay immediately and if payment is not forthcoming, we will engage debt collectors.

1. Overview

1.1 Multiple residents have reported that there are not enough activities for older children and teenagers to engage in. There have also been persistent multiple reports of anti-social behaviour in town, particularly during the summer months of gangs of youths causing mischief probably due underlying boredom and lack of cash to finance activities

2. Proposal

2.1 This proposal is therefore for BTC to organise an event where local clubs, organisations and societies can showcase their activities to local older children and teenagers with the aim of engaging them in long lasting positive social engagements whilst bolstering our community organisations.

This will give them the chance to be with their age cohort in person, make friends, learn skills whilst meeting positive role model adults.

2.2 There are two options to hold the event:

- During the summer holiday period at Whitelands or similar location
- In term time with our secondary schools hosting the event within the school day to maximise the chances of the target audience attending

2.3 BTC would sponsor the event by hiring a venue to host the event or look at using BTC premises to hold the event (Whitelands, Garth Park).

2.4 Sponsorship funding to be discussed and would depend on the nature of the event. A provisional budget of up to £250 to cover administrative and advertising costs is suggested to be drawn from Reserves, to be identified.

2.5 For the inaugural event we would extend the invitation to a wide range of clubs including Sports, Youth, St Johns ambulance, BBOWT and clubs further afield. Several groups have been approached on a casual basis and have expressed support.

- 2.6** For the inaugural event we would not charge a fee to organisations other than a refundable deposit to guarantee attendance. This is for councillors to decide upon.
- 2.7** It is the council's intention to focus more on this age group in future years to reduce antisocial behaviour, improve citizenship and help our young people develop skills and increase networks.

1. Overview

- 1.1** The external wall around the park is of historic value but has fallen into disrepair in places with some sections already collapsed. This presents two issues firstly the health & safety obligations we have as an authority to the public and visitors to the park but also in maintaining what is the original wall to the house and estate.

2. Proposal

- 2.1** Officers propose to have the remedial urgent works completed on the perimeter wall to bring the main walls into a good condition and once this has been completed to look at an annual inspection to check for any further issues before they escalate.

- 2.2** Urgent repair work is required on the following walls.

- Stables Yard Outbuilding
- Coner section extending to garages
- Internal side of boundary wall

3. Quotations

- 3.1** Supplier A **£42,229.50** (Not including VAT) HARI STONE

- 3.2** Supplier B **£13,870** (Not including VAT)

- 3.3** In line with Finance regulations, Officers have attempted to obtain 3 quotes. Five suppliers have been approached but only two have responded.

- 3.4** Supplier A has experience with Cotswold stone walls, the quote takes into consideration replacement of 50% of the stone due to frost damage, traffic calming, security fencing and materials including mortar which is in keeping with the historic nature of the wall.

- 3.5** Supplier B is a general builder and has quoted only for the wall to be repointed and does not have the skills for a complete rebuild if required.

1.1 The outdoor team's handheld machinery is starting to get beyond its useful capacity and with the best of intentions to repair as much of it as possible we are struggling to keep things running to enable the team to carry out daily works. The team need some new and up to date handheld equipment

4. Overview

1.1 Bicester Town Council has three operational vehicles, all fully utilized. Two vans are used for day-to-day work, and an electric van is used daily for play area equipment repairs.

1.2 Staff often require a vehicle to be able to attend Whitelands or collect goods and services for BTC. Due to not being able to have access to a vehicle Officers have previously used their own vehicles, this has now been stopped due to health and safety issues (not covered by business insurance) and personal running costs not recovered.

1.3 The Service Manager is now responsible for the Grounds Maintenance contract and is on call 24/7. A suitable vehicle is required to respond to emergencies, including fallen trees, damaged BTC structures. Alarm calls, vandalism

2. Proposal

2.1 Environment Officers have investigated options and determined that a 4x4 vehicle would be the most suitable. During office hours, the vehicle will be used as a pool car for staff and a response vehicle for the Service Manager during out-of-hours callouts. During BTC events the vehicle can be used for towing and hauling equipment, and transfer of personnel. The vehicle will be a pool car and covered by the existing vehicle insurance.

2.2. Environment Officers have also investigated the electric commercial vehicle market. The only viable fully electric 4x4 pickup available in the UK is £55K +, and it has a poor rating due to limited performance and expensive repair costs.

2.3 The vehicle will be white to match the existing BTC fleet.

2.4. Environment Committee Councilors requested the consideration of leasing the vehicle rather than purchasing. For comparison purposes, the purchasing prices are listed below:

We have completed a sponsored walk to raise some money to develop a sensory garden but are requesting additional funding to enable us to develop this further and purchase some additional resources for the children. Parents of the children who use the unit have supported by helping to prepare the area for the children to plant and have also supported by providing sponsorship for their children.

7. How does your project meet the criteria set out in 2.6 of the Grant Aid Awarding Policy?

I believe we meet the criteria set out in 2.6 as we have raised most of the funding ourselves through a sponsored event which the children participated in and also through some donations of resources, e.g. tyres, planters etc. An Oxford based charity (Farmability) made planters for our garden and donated these to us. The project supports inclusion as it enables our children to participate fully in the life of the school and to have an area which is suitable for their special educational needs.

2. Brief description of organisation:

ABILITY aims to provide a reliable and accessible on demand bus service for residents in the community who find it difficult to access public transport. Our aim is '*connecting people with places*'. ABILITY was created due to the significant government cuts to public transport. With a fleet of 9 minibuses, we take residents in the area to travel on a demand basis. Most of our members are elderly and over the age of 65 and our service assists people with mobility issues.

The service is open to all, and we aim to make it easier for the passengers to reach essential services such as food shopping, banking services, medical appointments, and local recreational events. We accept concessionary bus passes and charge a mileage fee for non-bus pass holders. Passengers can go and do their shopping at a variety of local supermarkets and our drivers some of which are volunteers then help members with their shopping to their door.

ABILITY also offers trips out to residents to places such as garden centres and shopping centres which encourages physical activity and making friends which helps to reduce social isolation.

We strive to give our members the freedom and confidence to get out and about on their own to keep physically active, meet new people, and make lasting friendships.

6. Details of **Specific Project** that funding is applied for (**see Grant Aid Awarding Policy 2.4**). **Only grants that comply with the criteria will be considered.** NB applications for running costs will not be considered except in exceptional circumstances which you must evidence.

We wish to grow the number of passengers from Bicester using the on-demand service. There are currently 55 members in Bicester, but we believe there are many more people in the Bicester community that need and would benefit hugely from using our service. To be able to grow the numbers of passengers in Bicester we need to market the on-demand service in Bicester and surrounding villages.

We will market the service in Bicester by placing leaflets, poster and banners in areas where there is a high footfall of the community. We will also host coffee mornings with

groups such as careers or go into retirement homes in Bicester to inform those who could most benefit from using the ABILITY buses.

We are currently connecting with key stakeholders in the community and are meeting with Tamsin Ireland the new Local Area Coordinator based in Bicester East to talk about our service so the details can be passed on to people within the Bicester community. We will continue connecting with key stakeholders to increase the awareness of the service and reach those in the community who will benefit from using the ABILITY service.

7. How does your project meet the criteria set out in 2.6 of the Grant Aid Awarding Policy?

The grant will be used solely for the marketing of the ABILITY Service in the community of Bicester. The marketing team will travel and attend in person events that vary from local parish groups, such as memory hubs, W.I. meetings and local coffee mornings with carers and Social Prescribers. These meetings will provide a great platform to promote the services and connect with those in the community who need the service the most. The use of marketing materials will be used for example leaflets and posters to be put out in places where there is a large footfall of the public i.e. doctors' surgeries.

Our experienced marketing team have marketed the service previously to different areas and communities with great success growing the number of people using the ABILITY service. Therefore, we are aware of what is required to be able to market and reach out to the community to increase numbers and believe the grant in which we are applying for is realistic and appropriate. The grant will enable us to grow the number of people in the Bicester community using the ABILITY bus to help with their travel needs.

Ability endeavours to provide a local transport service for residents living in more isolated areas. In delivering a regular shopper bus service to these areas, we make it easier for users to remain connected to the wider community, whilst maintaining some much-needed independence and freedom without having to rely on friends or family for lifts.

Through the company's activities, we aim to promote greater integration of communities across the areas we operate in. This provides great benefit to the community, particularly those currently reliant on public transport services, in offering an efficient and cost-effective transport service which provides access to essential services such as healthcare, shopping, education and employment. ABILITY will also support the economy by increasing access to local businesses, whilst promoting the development of a greener transport network with less congestion on busy roads, reducing harmful carbon emissions.

Users of the service can maintain their independence and attend doctor's appointments, hospital appointments, optical appointments, supermarkets, banking services, community groups and many more places in the community. Our service operates 5 days a week and we deliver an average of 30,000 passenger trips per annum, (i.e. to garden centres and shopping centres) at present and we have no doubt this will increase due to the need out in the community.

Our social mission is to help tackle loneliness and social isolation by providing a reliable, timely caring bus and car service open to all. People who are not able to access transport can lose their independence and this can have serious implications for

people's mental and physical health. Giving our members the confidence to get out on their own, meet new people and make lasting friendships is at the heart of what we do. Our mission is to ensure that we provide passengers with accessible, affordable transport, to a variety of locations. Our service is available to everyone and aimed at people who do not have a local bus service which gets them to where they need to go for example supermarkets and the doctor's surgery.

Our aim is to ensure anyone living in an isolated rural area has reliable access to essential services. We offer weekly buses into the main shopping areas of Banbury, Bicester, Brackley, Daventry, Milton Keynes, Northampton and Towcester. All services operate on a flexible route, meaning we can pick passengers up closer to home, and drop them off where they need to be – meeting individual needs.

The Bicester Town Council grant we feel is the most appropriate grant because our service directly aims to help some of the most isolated residents in Bicester with their transport needs.

ABILITY is managed with an experienced Board of Directors with relevant experience conducive to the requirements of the organisation, such as; project management, I.T., marketing, and previous Directorships held with a Blue Chip Company.
